KTDFC will not be responsible for any postal delay or misplacement of Tender documents sent by post. Tenders will be opened as per Tender Schedule given above in the presence of the interested tenderers or their authorized representatives whoever are present, at the Head Office of KTDFC.

- 4. Tenderer (s) shall indicate complete specifications and all features of the UPS Batteries.
- 5. In case the information submitted by the tenderer is found to be incorrect/false, at any stage, tender of such party will be rejected and Earnest Money Deposit (EMD) will be forfeited.
- 6. KTDFC reserves to itself the right to reject any or all the tenders without assigning any reason thereof and to call for any other details or information from any of the tenderers.
- 7. MD,KTDFC shall have the right to postpone/extend the date(s) of submission/opening of bids.
- 8. The selected tenderer shall supply, install and calibrate the item with 20 KVA APC make and 10 KVA Socomec make UPS and remove the existing Batteries, within 15 days of the date of receipt of purchase order.
- 9. If the selected tenderer fails to supply, install and calibrate the UPS Batteries within the said period of 15 days, KTDFC shall be entitled to cancel the purchase order given to the tenderer and forfeit the earnest money deposited by him/them along with the tender forms without giving any notice and without any obligation whatsoever and make alternative arrangements for the said work.

- 10. The earnest money of unsuccessful tenderers, other than the second and third highest bidders, will be refunded within 7 days of the finalisation of the tender. As regards the second and third highest bidders, earnest money will be refunded within 7 days after the supply and installation of the item. No interest will be given on E.M.D.
- 11. Acceptance or non-acceptance of any tender shall rest with Managing Director, Kerala Transport Development Finance Corporation Limited, Level-8 (6th Floor), Trans Towers Vazhuthacaud, Thiruvananthapuram-695014 at his/her discretion.
- 12. Non-compliance with any of the conditions given herein may lead to the rejection of tender.
- In the event of any default, failure, negligence, breach or violation, in the opinion of KTDFC, on the part of the selected tenderer in complying with all or any of the conditions, KTDFC will be entitled and be at liberty to revoke the purchase order, by serving 7 days notice in writing. In such cases, the loss and damages caused to KTDFC, if any, will be recovered from the selected tenderer by taking legal actions including actions as per the provisions of the Kerala Revenue Recovery Act. Similarly KTDFC shall also have the right to recover any other amounts due from the selected tenderer by taking recourse to the procedure above mentioned.
- 14. Selected tenderer is liable to pay the required GST and other taxes as are applicable, as may be decided by Central/State Governments from time to time. KTDFC shall not have any responsibility in this regard.
- 15. Only manufacturers having <u>CE certification</u> or authorized distributors of such certified products can participate in the tender. The tenderer should submit proof of their manufacturing / authorized distributorship. This is subject to verification, if necessary.
- 16. Demand draft/Banker's cheque for 5,000/- as EMD and Rs.500/- for application fee in favour of Managing Director), KTDFC payable at Thiruvananthapuram should be attached with the tender.
- 17. Incomplete or conditional or optional tender will not be accepted. The optional either in model or in rates will not be accepted and the tender will be rejected.
- 18. The price must be quoted as per proforma for price schedule "Annexure A" both in words as well as in figures. It shall be inclusive of all applicable taxes, charges, levies, handling and transportation charges, etc. Overwriting of rates should be avoided. Tenderer must initial any cutting / rewriting / overwriting of rates. Nothing over and above the quoted price would be payable to the successful bidder.

- 19. In case the firm fails to comply the purchase order within the stipulated period and are not willing to perform the contract, the item will be procured from the next lowest tenderer and the difference of cost will be recovered from the first party by taking legal actions including actions as per the provisions of the Kerala Revenue Recovery Act.
- 20. The tender will be rejected without assigning any reasons if the firm/company or its owner/partner/director involves in any criminal case, declared black listed by any Govt./Semi govt. department/agencies etc.
- 21. The tendering firm shall also submit a declaration that the product offered by them is as per technical specifications of the tender.
- 22. The bidder should carry an on-site **comprehensive warranty/guarantee** of the item for a period of at least 36 (Thirty Six) months. It shall be the duty of the contractual firm to replace/repair any of the non-functional Batteries during the Warranty/Guarantee period. The tenderer shall invariably state the period of Guarantee/Warranty of the item offered
- 23. In case of any complaint during guarantee/warranty period, the firm must attend the complaint immediately and rectify the problem and/or replace parts on site of minor nature within 12 hours of the reporting of complaint. In case the problem is major in nature and there is need for prolonged repair work, suitable standby arrangement shall be made within 24 hours of reporting of the complaint. For this purpose, working hours would be from 10.00 AM to 5.00 PM (Monday to Saturday).
- 24. The tenderer shall have a maintenance base in Thiruvananthapuram.
